Rental Fee:

- Bathrooms (located in Kitchen Area)

#### 2. CLEANING REQUIRMENTS

- Remove all trash from building
- Vacuum & sweep
- Clean Kitchen Area (if used)
- Clean both bathrooms (toilet, sink, and floors)
- Wipe off ALL TABLES
- Wipe off ALL CHAIRS
- Leave Building in as good or better condition than you found it

#### 3. PROPERTY DAMAGE
