### **Cherokee Development Authority**

- All information has been submitted to DEQ for the water loss audit. First meeting will be on 2/10/21.
- Generator for Lagoons was scheduled to be installed 1/26/21. Due to how muddy the road was, installation has been rescheduled for next week.

#### City of Cherokee

- Election update
  - Special Meeting will be held on 2/4/21
    - Proposition 1 meetings
    - Proposition 2 money from trust fund
    - Proposition 3 investment of money from trust fund
- Parks and Streets
  - O After contacting AEC, I learned that we cannot place a streetlight at the corner of E170 Rd and Ohio Street due to that pole being a junction. Our options are we can place a pole 100ft to the east of that corner or 100ft south of that corner. To add a pole and light it would cost the City \$3,000 per pole/light.
  - Major street repairs have been completed
  - o When weather is warmer, will order load of asphalt to work on smaller potholes
- Community
  - NextLink antennas are installed and operational. Today NextLink internet was installed at the City Library, RO Plant, Airport, and City Pool.
- Fire Department
  - o Kyle Spade is no longer on probation. New bunk gear will be ordered for him.
- City Clerk
  - O Utility billing system was not updated for rates over 5,000 gallons (residential) or 3,000 gallons (commercial). Issue has been addressed.

## • Police Department

Officer Hall was involved in a departmental accident on 1/15/21 while responding to a call with his emergency equipment activated. Officer Hall was transported to an emergency room, where he was later released. OMAG inspected the vehicle on 1/21/21. Vehicle will be taken to Alva for repairs. Internal investigation on Officer Hall's departmental accident is ongoing.
