Cherokee Development Authority

- We have received our first payment of American Rescue Plan funds. Formal bids process has begun for AMI / Water Meter system. Bid opening will be November 4, 2021, at 2PM.
- We have received our results for Lead and Copper. There was only one location where minimal copper was located (0.002 mg/L).
- Water leak at Laundromat caused from changing meter. Tort claim will be filed.

City of Cherokee

- Street Department
 - Alfalfa County Abstract Co. has reported a leak in their basement. They believe the cause was from poor sidewalk construction. A Tort claim has been filed.

October Commission Report

Patrons in the Library

CCCL are still working off of a set of imaginary numbers, as we don't know the number of patrons in the library from last year to compare. However, in the month of September, CCCL was blessed with 481 patrons in the library. They came in for a variety of reasons--books, computer use, books and newspapers, Friends of the Library meeting, activities and book and nut sales. It was a good month.

Activities in the Library

In September, CCCL had 7 activities with attendees. Our most popular activity for youth is LegoMasters Builders. Open to all ages, but primarily attended by those under 12, LegoMasters Builders is an hour-long program that gives youth an opportunity to let their imaginations run. They have 2 thirty-minute long builds, one is guided (they have specific parameters to meet) and one is a thirty-minute free build so that they can build what they want to build. They very much enjoy it. CCCL staff enjoys their creativity!

Our most popular adult program continues to be our Adult Book Club (ABC). It meets once a month, to discuss a book that we have all read. We alternate nonfiction and fiction that we have all had a hand in selecting. Some books we like, some we don't, but it has been a fun experience.

All in all, CCCL had 48 attendees at activities in September.

Grants for the Library

In September, CCCL applied for 2 grants through the Oklahoma Department of Libraries, the Institute of Museum and Library Services and the American Rescue Plan Act. In all, CCCL asked for just under \$10,000 for the library and community. As of this writing, we have been awarded \$4,000 through the Oklahoma Department of Libraries and the Institute of Museum

and Library Services through a Health Literacy Grant. CCCL, partnered with Main Street Cherokee, Cherokee Public Schools and AEC will be installing a StoryWalk at the Nature Park to encourage our youngest citizens to get out into nature and move. The grant provides thirteen bases to hold pages of a book so that citizens can walk around the park to enjoy the entire book. CCCL will change the book every month so that there is a new book to read every month to encourage every citizen to make the effort to use the park. Activities and celebrations in the park are also part of the grant, and will be planned in the future.

Our ARPA grant should be awarded later in October (\$5,200 for digital books, digital audiobooks, and digital laptops for learning)

October in the Library

In October, we have fewer small activities, but more big activities. We are hosting a Pumpkin Decorating Contest, beginning October 18 through October 30. Pumpkins can be painted, dressed, redefined--anything but carved--and we will display them until November 1 when the winners are announced. We are also having an escape room for teens on October 28, and Trick-Or-Treating for all ages on Oct. 30.
