MANAGER'S REPORT

CHAD ROACH PRESENTED THE MANAGER'S REPORT:

- WHY IS THE CITY CLEANING OUT THE CANYON? THE CITY HAD GONE OUT ON BIDS TO CLEAN THE CANYON THREE YEARS AGO, HOWEVER THE COST OF \$300,000.00. CHEROKEE DOES NOT HAVE THE FUNDS TO COMPLETE THIS PROJECT. APPROXIMATELY 10-12 YEARS AGO THE CANYON WAS CLEANED OUT, HOWEVER IT WAS NOT MAINTAINED. CHEROKEE HAS FOUR BRIDGES WITHIN THE CITY LIMITS, ONE BELONGS TO ODOT, ONE BELONGS TO DISTRICT 2 AND THE OTHER TWO BELONG TO DISTRICT 1. THESE BRIDGES FALL UNDER OKLAHOMA DEPARTMENT OF TRANSPORTATION'S BRIDGE INSPECTION PROGRAM. TREES AND EROSION ARE THE LEADING CAUSE OF BRIDGE FAILURE AND THE REPORT ON THESE REQUIRE THE REMOVAL OF TREES ALONG THE BRIDGE. THE CORE OF ENGINEERS IS LOOKING AT DECLARING THE CANYON A WETLAND WHICH WOULD PUT THE CITY UNDER THE FEDERAL CLEAN WATER ACT REQUIRING A 401 CERTIFICATION. THIS WOULD MEAN NO STORM WATER, OR ANY WASTE WATER ALLOWED IN THE CANYON, AND WE WOULD HAVE TO BE 404 PERMITTED TO DO ANY REPAIRS TO THE CANYON. PROBLEM WITH THIS IS THE WATER PLANT RELEASES ALL ITS WASTE WATER, WHILE IT'S CLEAN WATER IT IS STILL CONSIDERED WASTE WATER BY DEQ AND ALL THE WATER THAT FLOWS TO THE CANYON IS STORM WATER. THE WATER RELEASED BY THE PLANT IS REQUIRED TO BE TESTED AND INSPECTED BY DEQ BUT IT WOULD STILL BE A VIOLATION OF THE CLEAN WATER ACT. THE CITY IS STILL WORKING WITH FEMA TO REVISE THE FLOOD MAP AND OUR DRAINAGE AND MAINTENANCE IS THE FIRST THING THAT WILL BE CONSIDERED. THE TREES ALONG THE SWIMMING POOL ARE CAUSING ROOF DAMAGE AND THE DEBRIS FROM THE TREES CAUSE ADDITIONAL EXPENSE IN MAINTAINGING THE POOL. TREES CAN BE GREAT EROSION CONTROL IN THE RIGHT SITUATION; TREES CAN ALSO CAUSE EROSION.
