WE INCREASED THAT CD BY \$10,819.00. THE CITY RETURNED \$38,750 TO THE ELECTRIC FUND AND SAVED \$73,700 FROM THE SAFE ROUTES TO SCHOOL FUND. THE DESIGN IS COMPLETE FOR THE OHIO STREET WATERLINE.
