COUNCIL THEN DISCUSSED TAKING ACTION ON AUTHORIZING A LEASE-PURCHASE AGREEMENT WITH RCB BANK FOR 2023 DODGE DURANGO PURSUIT WITH EQUIPMENT AT A COST OF \$52,481.48 PURSUANT TO TITLE 62 O.S. SECTION 430.1. IN ADDITION, MONEY FROM INSURANCE THAT WAS RECEIVED ON THE CLAIM FOR THE OTHER POLICE VEHICLE WILL PAY OFF THE OTHER TWO POLICE VEHICLES. THE RADAR PACKAGE WILL BE PURCHASED SEPARATE FROM THE AGREEMENT.

LUKE HAGUE THEN MADE THE MOTION, SECONDED BY CHRIS MUHLBAIER, TO APPROVE AUTHORIZING A LEASE-PURCHASE AGREEMENT WITH RCB BANK FOR THE 2023 DODGE DURANGO PURSUIT WITH EQUIPMENT AT A COST OF \$52, 481.48 AND INSURANCE CLAIM PROCEEDS WILL BE USED TO PAY OFF THE OTHER TWO POLICE VEHICLES.


